### Virtual Meeting

The Meeting was called to order by Chair, Tracy Wrend at 8:16 a.m. Tracy requested Mark Hage and VSBIT staff who were present introduce themselves.

#### Items 1-3

Readings of the Roll Call of Members, Proof of Notice of the 2021 Annual Meeting and the Minutes of the previous meeting were waived. Jim Salsgiver, made a motion and Jeanne Collins, seconded the motion to waive the readings. The vote to waive was unanimous, the motion passed.

#### Item 4

Reports from the Officers and Directors were included in the VEHI 2021 Annual Report, which is posted on the VEHI website. Prior to the meeting, members were notified electronically how to access the report. Being there were no questions, Jim Peyton, made a motion and Mary Niles, seconded the motion to accept the VEHI Annual Report. The vote to accept was approved, the motion passed.

### Item 5

Tracy Wrend opened the meeting to questions concerning VEHI Programs.

Jim Salsgiver asked whether or not, once the state wide health care negotiations results are out in December, can VEHI give an expectation on the impact of health care cost in the state based on results. Bobby-Jo advised the FY 23 rates were just filed which take us from July 2022 to July 2023. It is our understanding that the last best offer are not very different from where they are today. We have made some adjustments, the last couple of years to make sure we account for any changes in utilization based on plan design. Because the last best offers are not that different from where we are today, we would not expect a big shift but are watching that on a year to year basis, watching where folks fall plan to plan. When watching utilization, COVID has had a big impact. While the first year COVID actually helped as

there was a reduction in claims due to medical offices being closed for a few months. With the Delta variant coming in, as of yesterday, the daily total in Vermont has skyrocketed. COVID could affect our current fiscal year of FY 22 and FY 23. Bobby-Jo also explained the rates are filed on a fiscal year basis, currently for July 2022 through June 2023 and the new commission benefits will take effect January 1 of 2023 for three calendar years. Jon Steiner also mentioned the e-mail on rate indication, hoping members are happy with the 5%.

Tracy thanked all for taking the time to join the meeting.

There were no indications of any other business. Motion to close the meeting was made by Zach McLaughlin, and seconded by Jim Peyton. The vote to adjourn was unanimous. The motion passed.

As there was no further business, the meeting adjourned at 8:27 a.m.
